

Navarre Beach Fall Festival of the Arts Artist and Crafters Vendor Application Information:

Festival Dates: October 10, 11 and 12, 2008

Friday, Oct. 10 – Vendor Set UP, Latin Night Entertainment

Saturday, Oct. 11 – 10 am to 6 pm

Sunday, Oct. 12 – 10 am to 5 pm, Vendor Tear Down

Location: Navarre Beach Parking Lot/Behind Cocodrie's Restaurant off Gulf Blvd.

Entry Fee: \$75.00 on or before September 15, 2008 (10 x 10 space)
\$100.00 after Sept. 15, 2008

1. Each entrant must have their own tent, display racks, tables and chairs. If you require electricity, you must indicate that. We have about 3 or 4 spaces that may accommodate that request.

2. Entry Fee and Signed release form and photos must accompany this application. Your application will not be reviewed without it. Application and fee are not guarantee of acceptance. No refunds will be available after October 1, 2008, or for weather, acts of God, civil disobedience or any circumstances deemed out of sole care or custody or control by GNBA, INC.

3. Acceptance in the show is a commitment from you to show all hours listed above. We do not have good lighting after dark, so you must close down at dusk.

4. Acceptance and assigned space in the Fall Festival of the Arts is non-transferable and booth space cannot be shared unless approved by GNBA. (Exceptions will be art gallery and other local art organizations/groups). The GNBA festival committee reserves the right to remove misrepresented or inappropriate materials from the show. GNBA reserves the right to sell soft drinks, water, festival posters and T-Shirts.

5. Exhibitors are responsible for collecting and reporting Florida Sales Tax.

6. There will be continuous security; however, it is in the vendor's best interest to secure valuables nightly. GNBA assumes no liability for loss, damage or misplacement of merchandise and equipment for any and all cases.

7. If you bring your children or dogs, please have adequate shelter, water and secure arrangements for them.

8. Loud music or loud speakers not allowed. No trailers, cars or carts will be allowed in the vendor area after set up is complete on Oct. 10, 2008.

RELEASE:

I understand and will comply with the rules and regulations set forth in this application and agree to abide fully with these rules. I understand and agree that the Greater Navarre Beach Arts Assoc., Inc. (Coordinator of event) is not liable in any way for damage, loss or theft of my personal goods, my tent contents, or my customers, and agree to indemnify and hold harmless GNBA and the GNBA Festival Committee against such loss, damages or theft.

In the event that GNBA, Inc. is unable to hold the 2008 Fall Festival of the Arts in October, 2008, by reason of war, acts of God, or acts of nature, or any other reason, or the Festival is interrupted in any way, no refund shall be made and it is agreed that all contracts are null and void.

There shall be no responsibility or liability on the part of GNBA for any losses sustained by any person caused by such event. GNBA in no way guarantees any return or benefits to vendor.

It is further agreed: GNBA assumes no liability for any injury to person or property or other damages or losses occurring on the festival premises during the Fall Festival of the Arts. I agree to forever indemnify and hold harmless GNBA, Inc., from and against any and all claims for loss, death, or damage of person or property and any other loss whatsoever arising out of any act, omission or negligence in the operation or conduct of me/my business, including violation of any law and all attorneys fees and costs incurred by those parties.

All of the release information must be agreed to in consideration of and as a condition of acceptance of me/my business as a vendor in the 2008 Navarre Beach Fall Festival of the Arts. The indemnifications provisions shall survive after the 2008 festival.
